Dear Parents and Guardians,

It's hard to believe that it is time to Registration for the 2018-19 school year. We are excited to share with you that the Consortium Board of Directors has set the tuition rate to reflect only a \$10 per month tuition increase over a ten month pay period!

Registration for current families and our 16 supporting Consortium Parishes will be February 12<sup>th</sup>-15<sup>th</sup>. If you are a current family, you will again be able to register from the convenience of your home by logging into your Sycamore account. You are also welcome to join our new families from our support Parishes and register Thursday, February 15<sup>th</sup> during Parent-Teacher conferences. Workstations and staff will be available to assist with the registration process. Registration for new families will begin Friday, February 16<sup>th</sup>. Every year, the cost to educate our students is adjusted to reflect the increases in the cost of living. One of our largest operational expenses is teacher salaries and benefits. We are grateful to our dedicated teachers who provide the best possible education to our students. To honor their continued commitment to Catholic education, we are providing an annual salary increase to reflect the cost of living increases in our community. This helps us retain our experienced, remarkable teachers who give so much to our schools and your children. The 2018-19 Kindergarten through 8<sup>th</sup> grade monthly tuition increases based on 10 months are as follows:

1 student family: \$10.00 per month	4 student family: \$27.50 per month
2 student family: \$14.00 per month	5 student family: \$32.50 per month
3 student family: \$21.00 per month	

We recognize the sacrifices you make to provide your children with a Catholic education at our schools. We understand our obligation to offer a first-rate educational program, rooted in our Catholic faith. Our schools continue to operate with some of the lowest tuition rates of the 16 Catholic elementary schools throughout the southeast and southwest metro area. We convey this point to instill confidence that fiscal responsibility is one of our top priorities.

Through this collaborative community of schools, we will continue to look for ways to manage costs efficiently and explore ways to raise additional funds through grants, individual donors and foundations. However, tuition will continue to be a vital source of income for our schools.

Enclosed you will find the tuition rates for the 2018-2019 school year. There is a non-refundable registration fee of \$100 per student. A minimum registration fee payment of \$100 per family is due at registration. Any remaining registration fee balance will be included in your tuition balance. A spot for your student(s) will not be held until the \$100 minimum registration fee is received at the school office.

Our faculty and staff are committed to providing your child with the best possible education, and we are grateful for your commitment and continued support to make that possible.

### Tuition payment plans through FACTS Management Inc.

The Consortium school tuition payments are transacted through our tuition management company, FACTS Management Inc. Once you have completed your school Sycamore registration and paid the required registration fee, you will receive an email from FACTS Mgt. asking you to go online to set up your payment plan. Use the information in the email to access your FACTS Mgt. account and set up your payment plan. Choose a payment plan that best fits your financial situation\*. If you have questions regarding payment plan options, please call the Consortium business office at 402-590-2810 or 402-590-2817 (Spanish). Office hours are Monday through Friday, 8am to 5pm.

## Our Mission

### Giving Parents a Choice. Giving Children a Chance.

Children's Scholarship Fund of Omaha (CSF) believes that all families, regardless of income should be able to choose the best educational setting for their children. The mission of CSF is to provide partial- tuition scholarships so children from low-income families can access the private or parochial K-8 education of their choice. By providing scholarship assistance during the time a child's educational foundation is being established, CSF believes that it is helping prepare children for continued success.

#### We Are Unique

CSF is the only independent scholarship granting organization of its kind. We are destination-neutral and have no religious affiliation. Children attend approximately 80 different schools throughout Omaha and northeast Nebraska.

#### We Require A Commitment

When a family receives a scholarship they must make their own commitment. CSF parents/guardians must contribute a minimum of \$500 towards their children's education each year, and each scholarship recipient must maintain a minimum 90% attendance rate. In addition, they must enter their child's school twice yearly to complete paperwork that monitors these requirements.

#### We Make a Difference

Once a child receives a scholarship he/she will continue to do so through 8<sup>th</sup> grade graduation, and siblings receive the same opportunity. We estimate that the cost to graduate each student currently receiving a scholarship is nearly \$11 million.

## Do we qualify?

Use the income guideline chart below to determine if you qualify. You will need to consider all forms of income including: Wages, child support, SNAP (food stamps), ADC/Public Assistance, Social Security Benefits, Public Housing/Section 8, other government assistance, and other income. Add all of your income amounts and look to see if you fall within the income guideline chart below.
