Consortium Families,

Thank you for your continued support of our schools and for trusting our Consortium schools with your children's education. It is an honor we take very seriously.

This letter outlines the tuition for the 2023-2024 school year. As you are surely experiencing, the cost of everything along with wages is all going up. Consequently, our tuition needs to rise to keep pace with the cost increases. The tuition for your first student is increasing 4.4%, well below the current rate of inflation. Our registration fee has been \$100 per student since 2012 and is the lowest among the Catholic schools in Omaha. This fee is being raised to \$150 per student. We will continue to carefully monitor tuition and fees in other Catholic schools and nearby preschools to ensure our tuition and fees are fair. All tuition rates are detailed on the Tuition Rate Sheet.

Re-enrollment for current students begins February 6, 2023. Enrollment for new students begins February 13, 2023. **Enroll the week of February 6th to confirm seats for your child(ren) as some classes in our schools are full.** This current year's tuition must be paid in full or other arrangements made with the Consortium Business Office for your child(ren) to start next year.

One of the best ways to keep our costs down is to increase our enrollment. Please encourage family, friends, neighbors, etc. to bring their child(ren) to our schools. You can share with them that our test scores are noticeably higher than other schools in our area and that we bring our Catholic faith to our schools, our students and their families on a daily basis. We welcome students from all religions, ethnicities and financial status to our schools.

We continue to receive strong support from the 16 parishes that help fund our Consortium Schools. Please continue to be generous with your financial giving to your parish. This year, families registered in one of our Consortium parishes will receive a lower tuition rate for TK-8 students. This is reflected in the Tuition Rate sheet. Due to the community wide nature of the school, this does not apply to the Dual Language Academy. It also does not apply to Preschool or PreK

The Children's Scholarship Fund continues to provide many families with tuition assistance. We will again use the Children's Scholarship Fund application process for those interested in tuition assistance. This process is outlined on the enclosed form.

Please remember, we will not turn anyone away for the inability to pay.

Thank you for sending your child(ren) to our Consortium schools. It is truly a blessing to be with your child(ren) every day to see them grow academically and in their Catholic faith.

Omaha Catholic School Consortium Tuition Assistance Process Flow

Objective: Embrace all families and organize a tuition solution that will work for every family. No family will be turned away for the inability to pay.

1. All families wanting to be considered for tuition assistance for children in grades K-8 must apply via the Children's Scholarship Fund (CSF) application process. Very limited funds are available for Preschool and PreK tuition assistance. Families wanting to be considered for Preschool and preK tuition assistance need to contact the Consortium Business Office and provide their most recent tax return.
2. If you are NOT currently receiving assistance from CSF, please use this link: <https://www.csfomaha.org/parents-family/new-applicants.html>. Even if you received Consortium assistance in the past, if you did not also receive CSF assistance, use this application.
3. If you are currently receiving CSF assistance, **you must go through the requalification process each year** to continue to receive your CSF award. Current CSF applicants can use this link to apply: <https://www.csfomaha.org/parents-family/currentfamilies.html>.
4. To also be considered for Consortium assistance, families must check the box "to be considered for OCSC aid".
5. CFS will announce their awards in early July and these awards will be immediately applied to family's accounts in FACTS.
6. **Applications can be submitted starting February 13, 2023. The deadline for submission is May 6, 2023.**
7. The Consortium will grant tuition assistance to families who qualified for but did not receive CSF assistance. This amount will be 90% of the CSF amount.
8. All families receiving CSF or Consortium tuition assistance are required to set up an autopay account or make special arrangements with the Consortium Business Office. Failure to set up autopay or contact the Consortium Business Office to make other arrangements may result in assistance being withdrawn.
9. Families over income for CFS will be considered for Consortium Tuition Assistance if their family's situation has changed. This further consideration will require providing updated financial information to the Consortium Business Office.
10. Families that still need assistance can reach out for Latino Children's Scholarship Fund assistance.
11. As a final resort, families still needing assistance can contact the Consortium Business Office for final consideration.
12. Inner City Scholarship Funds will be awarded in October. These funds are only available for families with students attending Sts. Peter and Paul.

** Families registered in one of the 16 Consortium parishes (see attached list) that support our schools have lower tuition. This is consistent with working closely with our supporting parishes whose financial support to Consortium is vital. Please be generous with your support for your parish.

Pay in full discount of \$150 per family is offered for TK-8 tuition and must be paid by August 1, 2023.

Assistance from the Children’s Scholarship Fund (CSF) ranging from \$675 to \$1,750 per student is available for TK-8 students. The CSF application is also used for consideration for Consortium tuition assistance. **To be considered for Consortium assistance, you must apply for CSF assistance.**

Assistance from the Children’s Scholarship Fund (CSF) ranging from \$675 to \$1,750 per student is available. The CSF application is also used for consideration for Consortium tuition assistance. **To be considered for Consortium assistance, you must apply for CSF assistance.**

Note: Dual Language Academy Tuition is higher than other Consortium Schools due to the additional cost of hiring bilingual staff.
