2024-2025 Tuition Rates, Tuition Assistance and Payment Plan Information

Collected tuition and fees account for 51% of the total operating budget for the Consortium's six schools. The remaining amount is funded through our development efforts and through the generosity of Sunday collections at our 16 supporting parishes across South Omaha. 2024-2025 Tuition Rates

As our six schools continue their important work, operating needs and cost of living increases require us to slightly increase tuition and fees for the 2024-2025 school year. The K-8 rate for 2024-2025 will be \$4,245. The rate for Consortium parishioners will be \$3,745. Discounts for multiple siblings will continue.

The new tuition structure, including pre-school and pre-K tuition, is outlined below. Your investment in Catholic school tuition helps us maintain and improve the Consortium school experience for students now and in the future.

* Each family is asked to pay this \$150 fee for at least one student per family at the time of registration to reserve space for all. All other fees, including registration fees for additional students are included in the tuition total above.

** Families registered in one of the 16 Consortium parishes receive a discount beginning in kindergarten.

**Pay-in-full discount of \$150 per family is offered for preschool-6th grade tuition and must be paid by August 1, 2024.

Note:

- Outstanding tuition balances from prior school year(s) must be paid to attend the 2024-2025 school year.
- Limited funds are available for preschool and pre-K tuition assistance. Please contact the Consortium office at 402-590-2810 to discuss options and provide your most recent tax return.
- The tuition rates above apply to the following schools: Holy Cross, Our Lady of Lourdes, St. Bernadette, St. Thomas More, & Sts. Peter & Paul.

Tuition Assistance Opportunities

Ensuring our Catholic schools remain accessible and affordable for families in the southeast Omaha area is our top priority. The entire Consortium team is keenly aware of the financial challenges facing families, and we are happy to discuss the opportunities for financial aid for the upcoming school year. We want to make this transformational experience available to families no matter their financial situation. No family is turned away from our schools due to an inability to pay full tuition.

Each school year, the Omaha Catholic School Consortium provides more than \$1.2 million in tuition assistance to families in the form of tuition discounts and need-based aid. Between 40-50% of the student body benefit from tuition assistance.

Tuition Assistance is provided to current and incoming students through these Funds:

- **The Children’s Scholarship Fund (CSF) of Omaha** is an independent organization that provides income-based scholarships for children in grades K-8. Applications are available February-May annually.
- **OCSC Tuition Assistance and Latino Catholic Scholarship Fund (LCSF).** These programs are funded by generous supporters of the Consortium and our schools. These funds are used to aid Latino families who do not receive CSF or who need additional aid. To receive LCSF families must apply; application window is from February 12th, 2024 to May 5th, 2024. If you have questions or to apply, please call (402) 590-2810.

New This Year

- **Opportunity Scholarships of Nebraska:** *Is your child entering kindergarten or transferring from a Nebraska public school they attended for at least one semester?* If so, you are eligible to apply for Opportunity Scholarship Nebraska to receive tuition assistance. This is a separate application, and more information can be found at Opportunity Scholarships of Nebraska (nebraskaopportunity.org).

Note:

- **IMPORTANT DEADLINE:** To receive tuition assistance, families must apply via the Children’s Scholarship Fund application process. Applications open February 5, 2024, and the deadline is May 5, 2024.
- New families must apply to BOTH Children’s Scholarship Fund and Opportunities Scholarship Nebraska.

FACTS Tuition Payment Processing System

All Consortium schools use the FACTS Payment Processing System to collect payments for tuition and fees.

To Access:

- Current Families access tuition accounts online by logging into the FACTS SIS family portal at . Click “Facts Family Login” > “Facts Family Portal” > Log in with district code [ocsc-ne], username and password and once logged in click on “Financial.” New families can view tuition charges after they have completed the registration process through the same Family Portal. If you have questions or concerns, please call your school or Consortium Business Office (402) 590-2810.

Note:

- Any tuition assistance will be applied directly to your FACTS account after the tuition assistance has been awarded.
- All families who receive tuition assistance from CSF or OCSC are required to set up an autopay account inside FACTS, or to make special arrangements with the Consortium office. Failure to complete this step may result in assistance being withdrawn.
